Sir,

The undersigned was appointed as a Returning Officer by the managing committee of The Air Corporation Employees Coop. Thrift & Credit Society Ltd. vide letter dated 03.01.2019 by passing the resolution in the Managing Committee of the society on 01.01.2019 to hold the election of the managing committee of Air Corporation Employees Coop. Thrift & Credit Society Ltd., I.A. Premises, I.G.I. Airport Terminal-I, New Delhi - 110037.

In compliance of said letter dated 03.01.2019, the undersigned issued letter dt. 06.01.2019 to the President /Secretary of the society to provide the requisite documents alongwith list of enrolled members as well as list of defaulter members to the undersigned for conduct the election of the managing committee of the society under the provision of DCS Act/Rules. The undersigned collected the documents from the society vide letter dated 04.02.2019. After obtaining the list of members from the society, the same was displayed on the notice board of the society vide notice dated 07.02.2019 for calling the amendments if any in the list of enrolled members in the society. The undersigned issued the agenda notice dated 27.02.2019 for conduct the election of the Managing Committee of the society on 06.04.2019 (Saturday) in special general body meeting to be held at I.A. Premises, Jet Shop Open Ground adjacent to Test House, A-320, Terminal-II, I.G.I. Airport, New Delhi - 110037. The undersigned dispatched the agenda notice courier through DTDC to 3785 members of the society out of which 68 members were going to be retire up to 31.03.2019 who will not be eligible to contest as well as cast the vote in the coming election to be held on 06.04.2019 duly mentioned in agenda notices as per provision Bye-Laws of the society as per list of members provided by the society. I forwarded two copies of agenda notices to President/Secretary of society one for record and one for notice board of the society. As per certificate vide letter dated 22.01.2019 given by the society there was no defaulter members in the society. Two copies of the certificate of defaulter members were forwarded to Registrar Cooperative Societies one copy for record and other copy for notice board of the office.

As per agenda programme, the nomination form were issued free of cost by the undersigned on 22.03.2019 from the society office as well as office of the Returning Officer to the interesting members for contest the election of the Managing Committee of the society. The nomination forms duly completed were received by the undersigned on 23.03.2019. Nomination forms were filed by 34 members of the society for one Post of President, Two Posts of Vice President, and nine posts of members of managing committee of the society in which include two posts are reserved for women members. As per agenda programme, the nomination were scrutinized on 25.03.2019 and all the nomination forms were found valid and in order. The list of valid nomination forms was displayed on the notice board of the society as well as notice board of the Returning Officer on the same date at 5.00 P.M.

As per agenda programme, on the date of the withdrawal the nomination forms on 26.03.2019 two request applications of Smt. Kamal Jeet Kaur Badhan (M.S. No.222216) and Sh. Satish Kumar M.No. 271501 for withdrawal was received.

After finalization the list of contesting candidate on 27.03.2019, the same was displayed on the notice board of the society on 27.03.2019 at 11.00 a.m. as well as on the Notice Board of the Returning Officer.

After completing all the procedure as per special note of agenda notice dt. 27.02.2019 the special general body meeting of the society was held on 06.04.2019 (Saturday) at 8.00 a.m. at I.A. Premises, Jet Shop Open Ground adjacent to Test House, A-320, Terminal-II, I.G.I. Airport, New Delhi – 110037. The quorum of the meeting was observed upto 8.30 a.m. As per direction issued by the Registrar Cooperative Societies vide letter No. AR(BKG)/C.D. No. 107544613 / RCS/2019/1127 dt. 28.03.2019 Sh. Bhika Ram Meena, DANICS Deputy Registrar of the Registrar Cooperative Societies was deputed as an observer for the election proceeding of Air Corporation Employees Cooperative T & C Society Ltd. to present on 06.04.2019 and submit the report within two days.

But Sh. Bhika Ram Meena, DANICS Deputy Registrar was not present during the election proceeding on 06.04.2019. Due to not fulfill the quorum of the meeting, the said meeting was adjourned for fifteen minutes and again started at 8.45 a.m. on the same day i.e. 06.04.2019 at the same place as per schedule of the Agenda Programme. The process of the election was started immediately by sealing the Ballot Boxes for contest the election for the one post of President, two post of Vice Presidents, two post of Women Members and seven post of MC Members in the presence of the contesting candidates.

However, as per directions issued by the Registrar Cooperative Societies to arrange all necessary equipment/ Camera etc. to record the proceeding of the election to held on 06.04.2019 the Returning Officer appointed M/s S.R. Films C/8 Bharat Vihar Dwarka Sector-14 New Delhi-110078 to videography by fixing to videographer one at polling booths and second at the place to cast the votes by the member in the ballot boxes. Further on the protest on group of candidates allowed the permission to install their videographer at both places. As per protest by a group of contesting members further allowed to issued the ballot paper by the polling booth by duly signed by the Verify Officer. After taking above steps the polling was started at 9.15 a.m. on 06.04.2019 by duly sealed the four ballot boxes showing to the contesting candidates and videography of sealing procedure.

The certificate of Commencement of poll was taken by the contesting candidates at the presence commencement of polling. The polling was started at 9.15 a.m. and continued without any interruption up to 4.00 P.M.

The polling was closed at 4.00 p.m. on 06.04.2019 and the mouth of four ballot boxes were sealed in the presence of the contesting candidates. The poll was conducted peacefully, smoothly and without any interruption. Certificate of closing of poll was taken from the contesting candidates at the time of the closing of poll. After completion the polling process, counting process was immediately started on the same day and the result of the counting was announced as under:
